
- Unable to produce accurate Financial reports until October 2019. BOD now receives monthly Balance • Sheet and P&L

- Assets

 - o Our goal is to have one year of annual operating expenses on-hand as cash reserve
 - Minimum Requirement is to have 3 months of expenses (\$45,000);
 - Artistic Legacy Resource \sim \$63122 6% of the resource can be used per year for operating funds
- Liabilities
 - None! We do not have any debt or large payables.
- Artistic Legacy Fund
 - o \$1.4 million dollars in estate contributions pledged

Symphonic Band Outlook (Henco Espag)

- Spring Concert 2019
 - More difficult repertoire
 - o Increased ticket sales
 - o New venue
- Fall Concert 2019
 - o Tickets sales were up from last year
 - First fall concert in 4 years that was not programmed as a holiday concert
 - Audience survey
- Increase Outreach to expand audience demographics
- Outreach Coordinator Pam Santiago
 - Reached out to Sing for Hope organization
 - Connection with Harmony Group for school outreach

- American Classical Music Association potential for whole band to play for one of their events in October 2020
- Auditioned Wind Ensemble
 - Would act as an outreach group (more mobile and more potential for different kinds of gigs)
 - Would enable the band to have two Fall concerts
 - Provide detailed written proposal to band and hold a Town Hall meeting

Marching Band Outlook (Marita Begley)

- Performed at 20 gigs in 2019
 - Gig attendance up for every gig this year
- Added another assistant Drum Major
- Performed at iconic locations: Plaza Hotel, Guard performed at Delacorte Theater in Central Park, Stonewall Rally, Museum Mile, Hammerstein Ballroom
- Planning another fundraiser at Slate in February 2020
- Guard
 - Found free space for guard to rehearse
 - Guard will go to a permanent uniform
- Hold Marching Town Hall to discuss survey results and other issues
- Marching Season 2020
 - Increasing rehearsal time to 9:30 in May and 10pm in June
 - Need to reconfigure block formation
- Macy's Update
 - Need to create a production video to show the band's diversity
- 2020 is the Marching Band's 40th season

Joe Kluger Report (Rusty Riker)

- Board members and other band leadership met with consultant Joe Kluger in November 2019
 - How do we get members more involved?
 - How do we get more corporate members?
 - How do we break down tasks to empower members to take on more responsibility?
- Joe Kluger can facilitate a meeting with entire band membership
- Will look into donors, sponsorship and grants to pay for consultant fees
